Timeline

Temple Bright was established in Bristol in 2010. Three years later, we opened our London office in the "Tech City" district north of Liverpool Street.

The firm now has around 70 partners, spread between our two offices, with expertise in the broad range of practice areas described over the page. We have clients across the UK and beyond, ranging from individuals and owner-managed businesses to PLCs and public bodies.

Four promises to clients

We have developed a distinctive style of advising, for clients who seek an alternative to the traditional solicitors' approach.

Our starting point in 2010 was the question, "What would clients like to see lawyers do better?" Uncommercial advice, disproportionate and openended fees, excessive delegation and inaccessible partners have been common complaints as solicitors' firms have grown.

To solve these problems, we formulated an approach to advising which is summed up in four promises that we make to clients:

- We provide City quality advice for growing businesses.
- Our fees are reasonable with no surprises.
- We promise attention from your regular senior lawyer.
- We are accessible and responsive.

To keep these promises, we developed our partner-only business model. We see this model as vital to keeping our clients happy as our own business continues to grow.

The chambers practice

Our model derives its name from the barristers' chambers and ensures that experienced lawyers work on all aspects of our clients' affairs. We selectively recruit senior lawyers from City and leading regional firms. They have substantial autonomy, without big firm constraints. We do not provide advice through junior lawyers supervised by partners.

The chambers practice also retains certain features of the traditional law firm at its best. We are highly cohesive, combining expertise in all the main areas of law relevant to businesses. We work in multi-specialist teams, bringing the wide-ranging skills required for many transactions.

However, in our model such teams consist entirely of partners. This enables us to advise clients in an agile and pragmatic way, capably matching the large, more conventionally structured firms that are usually across the table from us.
